CCTV Clarification Text Regarding the Processing of Personal Data

Identity of Data Supervisor

Your personal data may be processed by Ünver Grup Otomotiv Sanayi ve Ticaret Anonim Şirketi (the " **Company**") in the capacity of data supervisor as follows **within the scope of the Law on Protection of Personal Data No.6698 (the "Law")**. Personal Data and Processing Purposes

In order to record the work flow processes for product safety reasons and control the physical spaces for security reasons there are camera recorders inside the building and outbuildings (at the points where there are camera signs) and your audio visual recordings and physical space security data are obtained and processed by us in compliance with the Law and basic principles stipulated in the Law to secure the physical space, movable commodities and resources, create records of visitors and keep track of them, and informing the authorized persons, institutions and organizations.

Method and Legal Reason of Collecting Personal Data

Your personal data will be collected by means of electronic method and pursuant to Article 5 of the Law, your personal data may be disclosed to authorized persons, institutions and organizations in case it is obligatory for the data supervisor to fulfill its legal obligations, or in case data processing is obligatory for legitimate interests of data supervisor, or in case it is obligatory to establish, exercise and protect any right provided that it will not prejudice fundamental rights and freedoms of [personal data owners].

As personal data owners, you have the following rights under Article 11 of the Law:

- Being informed whether your personal data are processed or not,
- If your personal data are processed, requesting information in this respect,
- Being informed about the purpose of processing your personal data and whether they are used properly or not,
- Being informed about the third persons at home or abroad to whom your personal data are transmitted,
- Requesting correction of your personal data in case they are processed imperfectly or wrongly and requesting the third persons to whom your personal data are transmitted to be informed in this respect,
- Even if your personal data are processed in compliance with the Law and provisions of other laws, requesting them to be deleted or destroyed if the reasons that require them to be processed are not valid anymore and requesting the third persons to whom your personal data are transmitted to be informed in this respect,
- In case the analysis of the processed data exclusively made with automatic systems results in a circumstance to your detriment, raising an objection to this,
- Claiming your loss to be indemnified if you incur a loss due to unlawful processing of your personal data.

Your application will be finalized free-of-charge as soon as possible and within thirty days at the latest. In case the process you request requires an additional cost to be carried out, the fee will be charged to you in accordance with the tariff of fees determined by the Personal Data Protection Board.
